# **Monograph Materials Requirements**

The volume of 10-20 full A4 pages. Text editor - Microsoft Office 97-2003 / 2010.

Fields: top, bottom, right, left 20 mm.

Headset: Times New Roman, size - 14, line spacing - 1.5, paragraph - 1.25 cm.

In the center of the line in **bold** - the name and initials of the author (s), below - the academic degree, academic rank in the normal font, below the italics - the name of the institution.

Below - at one interval - the name of the material (in capital letters in bold in the center).

Below - at one interval - the text of the material.

At the end of the text - at one interval - Literature is given (bold and centered). List of references from 10 sources.

When compiling a list of references, the requirements of the International Standard APA-2010 should be observed.

Formulas, symbols, variables that occur in the text should be typed as Microsoft Equation objects.

Figures and tables should be clear and compact and folded using Microsoft Office tools.

Working languages: Ukrainian, English.

No later than the deadline must be submitted to the email address of the organizing committee <u>nauka\_oo@ukr.net</u> copyright information and text materials.

Upon receipt of the materials, the organizing committee within two working days sends to the author's email the message "Materials received" and sends the details for payment for participation in the monograph. All materials will undergo scientific review and literary editing. For authors who have not received confirmation of receipt of materials by the organizing committee, please duplicate the application or contact by phone.

The cost of publication in the monograph is \$2 for every full (or incomplete) A4 page.
